Templeton Unified School District makes student safety its highest priority. A Safe Schools Plan and Multi-Hazard plan are in place and reviewed and adopted annually. Our administrative staff has been trained in the National Incident Management System (NIMS). The Emergency Preparedness Committee actively reviews the district's emergency plans to further develop the district's response to emergency situations. Safety training is included in our annual staff development plans and tabletop exercises are conducted at each of the sites.
